

ANCHORINGS PLAN

HIRE OF BUOYS FOR ANCHORING VESSELS

MANAGEMENT: Roses Town Council, through the municipal company PORT DE ROSES, SA. In accordance with the plan for seasonal uses of the public marine and land domain of the municipality of Roses for the seasons 2017-2021. Reference: GI16012OT. Approved: 27/12/2016

BEACHES AND COVES: Jóncols, La Pelosa, Calitjàs, Montjoi, l'Almadrava, Bonifaci and Canyelles.

*Vessels of a length greater than 8 metres are prohibited from staying overnight at L'Almadrava, Bonifaci and Canyelles.

BUOYS; **White** (Restaurants, Hotels, Camping Sites). **Blue** (long-term hire) **Orange** (short-term and transient hire)

DATES OF USE: From 1st June to 30th September

DOCUMENTATION: Applicant's National Identity Card or passport and current insurance policy of the vessel.

HOW TO BOOK: Bookings can be made on the website of Port de Roses SA, www.portroses.com, at the port offices and on-site on the same day, on payment of the set price.

Bookings for long-term hire / blue buoys: These can be booked from the time the booking website is activated until 72 hours before the day of arrival or at the offices of Port de Roses SA.

Bookings for transient/orange buoys: via the website until 72 hours before the day of arrival. On-site if it is the same day, consulting availability with the Port of Roses boat master.

Half-day bookings. On-site, consulting availability with the master.

METHODS OF PAYMENT: cash, bank transfer or card,

BOOKING CONDITIONS:

The buoy number fixed by Port of Roses must always be respected.

It is prohibited to add any registration to the buoy or modify the anchorage in any way,

It corresponds to one buoy per vessel and it is prohibited to moor two vessels to a single buoy or anchor between buoys at any time.

The vessel moored to the buoy must be perfectly identifiable (name, licence number) and it must have an insurance policy which complies with the provisions of RD 607/1999 of 16 April.

The user of the booking may not transfer their booking to a third party in any case, even if this is a relative or friend.

The details of the vessel moored must coincide with the details in the booking. Otherwise, all the booking rights will be lost.

Users who have a buoy booked for the whole season or a long stay, and who do not occupy it for over three days (2 days in peak season), must notify the Port of Roses offices. Otherwise it cannot be guaranteed to be free on the day of their return. In no case may there be buoys free and unattended requests.

Arrival at the booked buoy must be between 10 am and 6 pm on the day of arrival.

Departure must be made at 10 am at the latest on the day of departure.

½ day times: 10 am to 2 pm and 2 pm to 6 pm

Night times: 2 pm to 10 am

CHANGES: bookings must be modified through the Port of Roses administration services. Changes are only admitted subject to availability.

BOOKING CANCELLATION: cancellations must be notified in writing. 75% of the deposit will be returned if the cancellation is made at least one month in advance, 50% if made at least one week in advance and 0% for less than one week.

INFORMATION: If you arrive at a field of buoys and find it fully occupied, you will have to anchor in a sandy area outside the field perimeter.

Safety factor: a wave less than one metre in height has been set as a safety limit, while for lengths of under 18 m, a wind force of under 25 knots and for lengths of over 18 m, a wind force of under 20 knots have been set. If these conditions are exceeded, Port of Roses accepts no responsibility for any damage caused to vessels.

The ferry service consists of transport within the same cove/beach from the vessels to land and from land to the vessels, for 2 persons (skipper and guest) during the hours set by Management.

The anchorages and buoys are checked periodically and if any are found in bad condition we would be grateful if you would notify the Port of Roses staff.
