- Offer: a total of 27 nights' moorings, maximum 1 in each port, free for our members in any of the other ports of the ACPET that participate in this promotion.
- Only the mooring is free of charge: consumptions, fees and services will be payable.
- Conditions: the applicant must be the proprietor of the vessel and the definitive holder of the mooring use rights or the direct lessee with the administration of the participant Port or Yacht Club, and in all cases he must be up to date with payment and have the civil liability insurance up to date.
- Bookings must be made with a maximum advance notice of 15 days and a minimum of 72 hours, and will entail the automatic authorisation of occupancy of the mooring in their absence.
- Bookings must be made obligatorily via the base port, which will confirm the availability and present a stamped form to the user, who will sign his acceptance of these conditions and the particular conditions of the regulations of exploitation and policing of the receiver port. This form must be presented obligatorily on arrival at the port of destination in order to enjoy this freedom of charge.
- No booking will be accepted which has not been made from the base port of the vessel in question.
- Any vessel which has made a booking and does not arrive at the destination port, without prior
  cancellation with a minimum advance notice of 24 hours, will automatically lose the rest of the unused
  nights it has night pending. If the proprietor wishes to recover those pending nights, he must pay at
  the base port the mooring fee of the destination port, and wait for the latter to reply to the base port.
- Vessels accepted: single-hull vessels registered in List Seven, of lengths between 8 and 18 m. For catamarans and greater lengths, the offer is much more limited and it will be necessary to consult explicitly the offices of each base port.
